RE: Authority to Sign University Contracts

University contracts may <u>only</u> be signed by *authorized employees*. Signature authority is derived solely from the chancellor by delegation or sub-delegation from an executive officer. The delegations are set forth in REG01.20.2 - Delegation of Authority to Sign Contracts located at:

http://www.ncsu.edu/general counsel/legal topics/contracts purch/DelegationofSignatureAuthorityChart.php A contract may be titled an "agreement," a "memorandum of understanding," a "memorandum of agreement," a "license," or a "contract." A contract does not have to involve money to create a legally binding obligation on the part of the university (e.g. internship agreement, affiliation agreement, confidentiality or nondisclosure agreement) but may involve other forms of valuable consideration.

Anyone who has not received signature delegation and who signs a contract that obligates the university or one of its divisions, colleges, departments, centers, institutes or programs is acting without authority and may be held personally liable for any breach of the contract or the value of the contract and may be subject to disciplinary action. N.C.G.S. §143-58 and REG01.20.2 (section 2.2).

There are certain clauses that the university is prohibited from entering into as an agency of the State of North Carolina. These include, but are not limited to, agreeing to be bound by the laws of another state and indemnifying a third party. Prohibited contract clauses are described at this link:
